RELEASOR expressly agrees that this release, waiver and indemnity
 agreement is intended to be as broad and inclusive as permitted by the laws
 of the State of Wyoming and that if any portion thereof is held invalid, it is
 agreed that the balance shall, not with standing, continue in full force and
 effect. releasor expressly understands that the hog wrestling involves an
 inherent risk of injury to oneself and to others. releasees are not liable for
 the injuries to those who participate in hog wrestling activities, or that are
 caused by watching the hog wrestling activities.
