LITTLE BUCKAROO RODEO ENTRY RULES

- Entries may be submitted online or in-person. All entries must be accompanied by payment at the time of entry.
- If mailing your entry form, please plan for it to be received at the fair office by Wednesday, July 21. If it is received after July 21, the late entry rules will apply.
- **Check-in time is July 28, 2022 between 6:00PM and 6:30PM.** Entry fees and the release below must be submitted by 6:30PM. If a release is not signed, or entry fees are not paid, the child will not be allowed to compete.
- Checks can be made payable to Sublette County Fair Board or SCFB.
- Parents: Please note that the animals in the rough stock events (mini bull riding, bareback riding, and calf riding) are very talented and intense bucking stock. Please be aware that there is risk for serious injury.
- *Late Entries: Late entries (after 7/20/2022) will be accepted, but entry fees will double. Absolutely no entries will be accepted after 12:00PM on Wednesday, July 27. All other rules apply.*
